## **WE Energies**

Q: Who is WE Energies' point of contact for DNC related projects?

**A:** Linda Schreier. Linda is the point of contact for ALL DNC related projects even if they are outside of her normal jurisdiction. Linda's contact info is as follows:

**Q:** Are applications needed for DNC related services?

**A:** Yes, applications are needed for all commercial & temporary services related to the DNC. An application is also needed even if the WE Energies is just reviewing a site for a potential service. **Any DNC related applications should be noted as such so WE Energies can assign them appropriately.** 

**Q:** Will WE Energies meet us on site or discuss a potential project, even if we have not been awarded the project yet?

**A:** Yes, for DNC related projects, WE Energies will meet with and discuss the planning of a project even if it is not a sure thing, or your company has not been awarded the project yet.

Q: What is the lead time for service connection on DNC related projects?

**A:** The more advanced notice the better. WE Energies needs about a 6 week lead time for projects. This can be more or less depending on the location of the project, and what type of system it employs. The sooner you can bring WE Energies into the loop the better.

**Q:** Will WE Energies have on call trouble crews available for after-hours support.

**A:** Yes, there will be after hour support available, the exact extent has not been determined. Once the exact details are available NECA will get the info out to the membership.

## **City of Milwaukee Electrical Inspections**

Q: Who will be the inspector in charge of DNC related inspections?

**A:** Matt Wojcik will be in charge of DNC related inspections, additional help will be provided if necessary to accommodate work load. Matt's contact info is as follows:

**Q:** Is there any special process for DNC related permits?

**A:** The permit application process is the same, but permits must be marked as DNC related. When filling out permit applications for **ANY** DNC related projects, the permit must be identified as such. This can be done under the "PERMIT TRACK" section of the permit. Under "PERMIT TRACK" select "YES", once "YES" is selected a drop down will appear, in the drop down select "2020 DNC".

**Q:** Will the City of Milwaukee have after-hours, or on call support for inspection services during the DNC?

**A:** The City is planning on having inspection services available for 2<sup>nd</sup> shift inspections. The exact details are not yet in place. NECA will get the information out to the membership when it becomes available.

Q: Is there anything electrical contractors can do to help expedite inspections for DNC related projects?

**A:** Yes, if the contractor has been awarded a DNC project, they can provide the construction schedule to the electrical inspector so they can plan accordingly. The sooner the City can be notified the better. The contractor can also make sure to provide any important project information and/or paperwork i.e. outlet location letters.
